


- Receiving notices of change (NOCs) on originated entries
- Receiving returns on originated entries
- Miscellaneous information

**This class strategically allocates its objectives into education on the receiving side (RDFI) in the morning and early afternoon, followed by the origination side (ODFI) later in the afternoon.**

The class reviews common issues and how to “get it right” including:

- Proper return codes and deadlines
- Stop payment versus written statement versus Regulation E
- Federal government benefit payment returns
- Originator due-diligence and exposure-limit requirements
- Origination by the financial institution of pre-authorized transfers and loan payments
